

# A reminder of where this has come from

### O July 2007: The Review of Sub-National Economic Development and Regeneration (SNR)

'a ratcheting up of the significance of local economic development'

### O SNR developed as a result of:

- Concern about dual and unequal places
- Complexity of strategy, funding, partnerships
- Unclear regionalism and lines of accountability

### O Three key elements to SNR

- Statutory Local Economic Assessments
- (Integrated) Regional Strategies
- Economic Prosperity Boards and other sub-regional mechanisms



### Why is LEA good?

- Statutory recognition for economic development function AT LAST!
- Recognises links between economics and other aspects of place
- Enables consistent and comparable local economic evidence bases
- Provides opportunity for in-house economic knowledge and assessment
- Provides the intelligence for improved economic development interventions



# What strategic issues does LEA address?

- Enables cross-authority and partner recognition of the importance of local economic development
- Presents a new way of thinking about local economic strategy
- Presents a mechanism for discussing 'development' as opposed to just 'growth'
- Enables a consideration of a wider resilience of place
  - Plan to link our resilience work and pilots to this network



# APSE/CLES Pilot Performance Network for LED

- Set up February 2009
- Primarily data and evidence focused
- Mechanism for comparing authority performance on suite of LED indicators using APSE PN framework
- 23 local authority members
- 1 round of data analysed and three network discussions



# **Lessons learnt from Performance Network**

- Data collection is just the starting point.
- No shortage of data and evidence so any network needs to add value
- Difficult to develop comparable LED indicators
  - Very varied local economic picture
  - Economic development not like other Local Authority services
  - Different scales of assessments (City Region, Sub Region, MAA etc)
- Network engagement needs to be both face to face and virtual
- The need of practitioners is not just for performance discussions but wider LEA discussions
